ALL Swimmers enrolled in one of training programs with a Competition Requirement are required to complete, sign and submit this form.

I understand that I am responsible for all swim meet entry fees and will submit the Payment Information required below per our swim meet sign-up and payment policy. Swim Meet Entry fees for the 2017-2018 Annual Swim Season will not be subsidized. However, all swimmers are welcome to complete the Teams Assistance Application for help with Meet Entry Fees.

Swimmer's meet entry fees will be debited from your debit, credit card, checking or savings account. For each meet an additional \$10 will be added to each swimmer's meet entry fees charged by the Host Swim Team to help pay for Team expenses. If debited funds are returned for any reason your swimmers meet entry fees will be forfeited and their meet entry will be withdrawn.
